# DANSK OFFSHORE

Dansk Offshore is the industry association for the entire supply chain in the Danish offshore industry.

As a member of Dansk Offshore, you will be part of either the Oil Company Council or the Supplier Council.

### Supplier Council

Members of Dansk Offshore from the supplier or service industry with a direct or indirect interest in the Danish oil, gas and CCS sector (and who are neither possessing a license, license holders or license partners) will be part of Dansk Offshore's Supplier Council.

The Supplier Council independently appoints three members to the Board of Directors of Dansk Offshore. Furthermore, the Supplier Council will determine the level of the membership fee for their members once a year. The supplier council also acts as an advisory body.

The membership fee is calculated based on the number of FTEs working with oil, gas and/or CCS related activities in the company. Member companies will calculate the number of FTEs themselves once every year for submission to Dansk Offshore

### Oil Company Council

All members of Dansk Offshore with activities in Denmark as a company possessing a license, license holder, or license partner, will be a member of Dansk Offshore's Oil Company Council.

The Oil Company Council independently appoints four members of the Council to the Board of Directors of Dansk Offshore. Furthermore, the Oil Company Council will determine the level of the membership fee for their members once a year. The Oil Company Council also acts as an advisory body.

The individual membership fee is composed of the sum of a basis membership fee, a market share fee, and a separate CCS fee.

#### Associated members

Organisations and associations can become associated members of Dansk Offshore. Associated members have no voting right. Terms are agreed individually.
